



Season Ticket Waiting List - Terms & Conditions

CPFC Limited, Selhurst Park Stadium, Holmesdale Road, London, SE25 6PU (the “Club”). These are the terms and conditions on which the Club agrees to add you to the Season Ticket Waiting List for Season 19/20.

1. Non-Refundable Deposit

1.1 A £10 non-refundable deposit per seat is charged to join the Season Ticket Waiting List, redeemable against the cost of the Season Ticket upon purchase.

1.2 By paying the £10 non-refundable deposit to the Club, you accept the terms and conditions set out herein.

1.3 In order to benefit fully from being on the Season Ticket Waiting List you must ensure that the Club has your up-to-date contact details.

1.4 Unfortunately joining the Season Ticket Waiting List does not give you any entitlement to match tickets. If you want access to match tickets before you become entitled to purchase a Season Ticket pursuant to paragraph 2.1 below, we advise that you separately purchase a Membership.

2. Purchase of a Season Ticket

2.1 When you reach the relevant point on the Season Ticket Waiting List, you will be contacted and given the opportunity to purchase a Season Ticket.

2.2 Subject to paragraph 2.3 below, at part of the purchasing procedure, provided you have paid the £10 non-refundable deposit for the relevant Season Ticket(s), you or your nominated individual(s) will be allocated a Season Ticket. If you chose to nominate an individual other than yourself for the Season Ticket, you will provide the Club with all information requested by the Club relating to the nominated individual. Upon confirmation by the Club, the nominated individual will become subject to any Club terms and conditions applicable to the Season Ticket.

2.3 Upon accepting a Season Ticket, the full payment (minus the £10 deposit) will become due.

3. Removal from the Season Ticket Waiting List

3.1 Should you decline to take up the Season Ticket when offered under paragraph 2.1 above, you may be removed from the Season Ticket Waiting List.

3.2 Should you breach: (i) the terms of any other agreement that you may have with the Club; or (ii) any Club terms and conditions applicable to you, or, if you are, or become, subject to any banning orders whereby you are prohibited from attending football matches, the Club may, at its sole discretion, remove you from the Season Ticket Waiting List. The Club will notify you of this decision in writing no later than thirty (30) days after you have been removed from the Season Ticket Waiting List.

3.3 The Club is a data controller in respect of personal data submitted by you and will hold and process personal data for legal and administrative purposes and, with your consent, for marketing purposes. The personal data provided to the Club shall be processed, stored and transferred in accordance with the Club's privacy policy, which is available at <https://www.cpfc.co.uk/cpfc-privacy-policy/>. We will use the information you give us to send you confirmation of payment of your deposit, your progress on the Season Ticket Waiting List, and to keep you up to date with

what's happening at the Club, for example news, competitions and Club special offers. We will also, with your consent, share your information with the Club's Official Sponsors and Partners so that you can receive information from us or them by post, telephone, email, online and by SMS about their products and services, latest news, special offers and competitions.

4. Miscellaneous

4.1 Without prejudice to the provisions of paragraph 4.3, the Club shall not be in breach of, or be deemed to be in breach of, any provision of these terms and conditions if it fails to perform any of its obligations under these terms and conditions by reason of any fact, matter or circumstance which is outside the reasonable control of the Club.

4.2 The Club shall not be liable to you, whether in contract, tort or otherwise, for any indirect, special or consequential loss or damage, or for any loss of profit or revenue, loss of use or enjoyment, loss of business or contracts, or loss of opportunity. The aggregate liability of the Club to you in connection with these terms and conditions, whether in contract or tort, including negligence, or in any other way, shall not exceed the aggregate amount of the deposit paid by you as at the relevant date.

4.3 Notwithstanding any other provision of these terms and conditions, the Club does not seek to exclude or limit its liability for death or personal injury caused by the negligence of any of its officers, employees or agents.

4.4 The Club reserves the right to cancel or vary the Season Ticket Waiting List process at any time and at its sole discretion.

4.5 The Club reserves the right to offer Season Tickets as prizes for promotion from time to time.

4.6 The Club reserves the right to, once it has offered everyone on the List the opportunity to buy a Season Ticket, offer the opportunity to buy a Season Ticket to supporters who did not sign up to the Season Ticket Waiting List.

4.7 These terms and conditions are governed by, and shall be construed in accordance with, English law. The parties agree that the Courts of England have exclusive jurisdiction to settle any dispute arising in connection with these terms and conditions and the parties submit to the exclusive jurisdiction of the English courts.
